- New Business:
- Art Auction Fundraiser
 - Cindy Van will contact Mary Lynn Worl to follow up on Mary Lynn Worl's offer to hold an art auction at her house and make it a fundraiser for the SCDP. The suggestion was made to create a planning committee with these people invited to participate: Mary Lynn Worl, Cindy Van, Patty Racich, Teryl Hartman. The Planning Committee will set a date for the event by the June central committee meeting.

 - Keep SCDP gatherings going at the precinct level every other month, organized by precinct committeepersons.
